**Halam Church of England Primary School** is a church school in the Diocese of Southwell and Nottingham. The Minster Trust for Education (MITRE) is the admissions authority for the school.

The School Admissions Code 2021 requires that all admission authorities undertake a statutory consultation to seek the views and comments of anyone who may be affected.

All schools must have admission arrangements that clearly set out how children will be admitted, including information about what happens if there are more applications than places available (oversubscription criteria). The criteria must be reasonable, clear, objective, procedurally fair and comply with all relevant legislation, including equalities legislation. It is for the admissions authority to decide which criteria are most suitable for the school, according to local circumstances.

From 11<sup>th</sup> November 2024 to 6<sup>th</sup> January 2025 the school is consulting on its admission arrangements.

#### **Reason for Consultation:**

The School Admissions Code 2021 requires admission authorities to consult on their admission arrangements at least once every 7 years, even if there have been no changes during that period.

The school is going out to consultation in order to be compliant with this requirement in the Admissions Code 2021. The school's admission arrangements are unchanged from 2025-26.

## Who are we consulting with?

The School Admissions Code 2021 requires that all admission authorities undertake a statutory consultation to seek the views and comments of parents/carers, other admission authorities, pre-schools, nurseries in the relevant area, Nottinghamshire County Council, neighbouring local authorities, Dioceses, and anyone else who may be affected by the consultation.

The consultation will run for a period of 8 weeks commencing on Monday 11<sup>th</sup> November 2024 and closing on Monday 6<sup>th</sup> January 2025 at 5pm. A copy of the School Admissions Code 2021 can be found at <u>School admissions code - GOV.UK</u>
